(Approving Nine Land Leases for Construction of HUD Housing)**

3 **WHEREAS, the Tohono O'Odham Housing Authority ("TOHA") was**
4 **established by the Legislative Council pursuant to Ordinance**
5 **No. 56 to construct federally funded housing projects for**
6 **members of the Nation in conjunction with the United States**
7 **Department of Housing and Urban Development ("HUD"); and**

9 **WHEREAS, TOHA has received funding to construct and operate a mutual**
10 **help housing project known as Project AZ 26-31 (the "Project");**
11 **and**

13 **WHEREAS, the Project involves the construction of mutual help houses in**
14 **the Sells, Baboquivari, San Xavier, Pisinemo, Gu Vo,**
15 **Hickiwan, Gu Achi and Sif Oidak Districts; and**

17 **WHEREAS, construction of the housing units requires that TOHA secure**
18 **leases of tribal trust lands for the Project homesites; and**

19
20 **WHEREAS, attached hereto are nine leases between TOHA and the Tohono**
21 **O'Odham Nation under which the Nation would lease tribal**
22 **trust lands for the Project homesites (the "Leases"); and**

24 **WHEREAS, each District in which homesites are situated has approved the**
25 **Lease relating to District lands; and**

27 **WHEREAS, the Housing Committee recommends that the Legislative**
28 **Council approve the Leases.**

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Tohono O'Odham Legislative Council approves the Leases in the form attached hereto.
2. The Legislative Council authorizes and directs the Chairman of the Nation to execute the Leases and submit them to the Bureau of Indian Affairs for approval.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5TH. day of JANUARY, 1993 at a meeting at which a quorum was present with a vote of 1,597.0 FOR; -0- AGAINST; -0- NOT VOTING; and 127.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 5 of Article XVI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


