

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Gu Achi District FY '93 Budget)**

RESOLUTION NO. 93-015

WHEREAS, the Gu Achi District Council has considered and reviewed its District Budget for FY-93 and has prepared a proposed budget to cover anticipated costs and expenses for January 01, 1993 - September 30, 1993; and

WHEREAS, the Gu Achi District Council did adopt and approve the proposed budget for FY-93 in the amount of \$136,008.13 for the Gu Achi budget; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed the proposed budget and approves the same.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Gu Achi District Budget to be expended in accordance with the attached budget.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council adopts and approves funding for the Gu Achi District FY '93 budget as follows: \$102,967.09 will be provided by the Nation's Special Reserve Account; \$33,041.04 will be funded from the District's funds.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH. day of JANUARY, 1993 at a meeting at which a quorum was present with a vote of 1,660.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham

Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


