Community Health Services under an FY 1993 P. L. 93-638
contract with Public Health Services, Indian Health Services;
and**

**WHEREAS, pursuant to Legislative Council Resolution No. 92-381
authorized the de-obligation of Fiscal Year 1992 carryover
funds and to re-obligate these funds into the Fiscal Year 1993
Contract; and**

**WHEREAS, the Community Health Services has prepared and submitted a
revised Scope of Work to incorporate the additional activities
outlined in the attached budgets/budget modifications for the
Community Health Division, Community Health Representative
Specialty Training and Community Counseling and Relations
Services to incorporate the re-obligated amounts for review and
approval by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 8TH. day of JANUARY, 1993 at a meeting at which a quorum was present with a vote of 1,355.5 FOR; 368.5 AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
