3 **WHEREAS, Section 1 (a) of Article II of the Constitution of the**
4 **Tohono O'Odham Nation provides that the Tohono O'Odham**
5 **Council can make additions and changes to the official census**
6 **rolls of the Sells and Gila Bend Reservations dated January 1,**
7 **1937 and of the San Xavier Reservation dated January 1, 1940,**
8 **subject to the approval of the Secretary of the Interior; and**

10 **WHEREAS, the Enrollment Committee has determined that the following**
11 **named person(s) was a member of the Tohono O'Odham Nation**
12 **on the date of the respective census rolls but that their name(s)**
13 **had been inadvertently omitted therefrom, and had**
14 **recommended that their name(s) be added to the rolls; and**

17 **WHEREAS, the Tohono O'Odham Council has reviewed the**
18 **recommendations of the Enrollment Committee and approves**
19 **thereof.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council**
22 **that, subject to the approval of the Secretary of the Interior,**
23 **the name(s) of the following person(s) be added to the official**
24 **census rolls of the Sells, Gila Bend or San Xavier Reservation,**



9 with a vote of 1,597.0 FOR; -0- AGAINST; 127.0 NOT VOTING; and 04
10 ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of
11 Article II and Section 1 (h) of Article VI of the Constitution of the Tohono
12 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
13 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
