3 **WHEREAS, the Legislative Council is empowered by Article VIII, Section**
4 **4 of the Constitution of the Tohono O'Odham Nation to appoint**
5 **judges of the Tohono O'Odham Courts; and**

7 **WHEREAS, the Legislative Council did, by Ordinance No. 01-89, Chapter**
8 **II, authorize the appointment of judges pro tempore to the**
9 **Tohono O'Odham Courts upon the recommendation of the**
10 **Chief Judge; and**

12 **WHEREAS, the Chief Judge has submitted the names of attorneys qualified**
13 **pursuant to 2-103 of Ordinance No. 01-89 and recommended**
14 **their appointment as judges pro tempore of the Tohono**
15 **O'Odham Courts; and**

17 **WHEREAS, Resolution No. 146-90 appointed judges pro tempore for terms**
18 **of two years; and**

20 **WHEREAS, three judges pro tempore terms have expired effective May 1,**
21 **1992; and**

23 **WHEREAS, the Chief Judge has submitted the names of three attorneys**
24 **qualified to fill the current expired terms of judge pro tempore;**

27 **WHEREAS, the Judiciary Committee has met with the Chief Judge and**

WHEREAS, the Judiciary Committee has determined that the persons recommended are of good moral character, residents of the State of Arizona for not less than five years, and are admitted to the practice of law for not less than three years; and

WHEREAS, the Judiciary Committee does concur with the recommendations of the Chief Judge and recommends to the full Legislative Council three appointments of judges pro tempore for the Judicial Branch of this Nation.

13 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).






