WHEREAS, the Tohono O'Odham Nation is presently operating the Family Preservation Program under FY 1993 P. L. 93-638 grant with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted to transfer funds within line items for review and approval by the Social Services Program.


NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Family Preservation grant and requests the Bureau of Indian Affairs to authorize expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated Official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.




