3 **WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a**
4 **new transmission line and related facilities to furnish electric,**
5 **water, and other utility services to the U.S. Customs Station,**
6 **Sells Community, Sells District, and has submitted a plat or**
7 **map thereof to the Tohono O'Odham Council showing the**
8 **location and scope of the easement and delineating the utility**
9 **facilities to be placed thereon; and the length of the line in the**
10 **Sells Community is 2700' X 40' wide; and**

13 **WHEREAS, the Tohono O'Odham Council has determined that the routing**
14 **and location of the easement for electric, water, and other**
15 **utility services is not in conflict with any land use plans adopted**
16 **by the District Council and approved by the Tohono O'Odham**
17 **Council, and that the new transmission line will be of**
18 **substantial benefit to the Sells Community, District, and the**
19 **Nation and to their respective members.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Council**
24 **does hereby approve the easement for the location and**
25 **construction by the TOUA of the new utility transmission line**
26 **and other utility services to serve the U.S. Customs Station,**


