Children's Home Program under FY 1993 P. L. 93-638 contract  
with the Bureau of Indian Affairs; and**

**WHEREAS, the Tohono O'Odham Nation did submit its FY 92 Final  
Financial Report which reflects unexpended funds; and**

**WHEREAS, any amendments affecting the funding or funding levels of the  
contract shall be submitted for review and approval by the  
Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval  
reflecting FY 1992 carryover funds by the Children's Home  
Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
Legislative Council does hereby approve the amendment to the  
Children's Home Program contract and requests the Bureau of  
Indian Affairs to carryover unexpended funds from FY 92 into  
FY 93 and authorizes expenditures in accordance with the  
attached budget.**


