3 **WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a**
4 **new transmission line and related facilities to furnish electric,**
5 **water & wastewater facilities services and other utility services**
6 **to the communities of Pisinemo & Santa Cruz of the Pisinemo**
7 **District, and has submitted a plat or map thereof to the Tohono**
8 **O'Odham Council showing the location and scope of the**
9 **easement and delineating the utility facilities to be placed**
10 **thereon; and the total length of the line for both the Pisinemo**
11 **Waterline & Tank Site/Pisinemo to Santa Cruz Waterline is**
12 **53,908.66' (10.209 mi.) in length X 40' in width. Tohono**
13 **O'Odham Council also approves allocation of property sites for**
14 **a Water Tank & a Well Site as set forth on attached drawings;**

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Council does hereby approve the easement for the location and construction by the TOUA of the new utility transmission line and other utility services to serve the communities of Pisinemo & Santa Cruz.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 4TH. day of MARCH, 1993 at a meeting at which a quorum was present with a vote of 1,499.0 FOR; -0- AGAINST; -0- NOT VOTING; and 225.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1 (i)(1) and Section 2(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
