

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving TOUA Utility Easement for Anegam Community)**

3 **WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a**  
4 **new main water line and related facilities to furnish all required**  
5 **utility services to the residence of Paul Andrew, Anegam**  
6 **Community, Sif Oidak District, and has submitted a plat or**  
7 **map thereof to the Tohono O'Odham Council showing the**  
8 **location and scope of the easement and delineating the utility**  
9 **facilities to be placed thereon; the length of easement in the**  
10 **Anegam Community is 707.95' X 40' wide; and**

13 **WHEREAS, the Tohono O'Odham Council has determined that the routing**  
14 **and location of the easement for all required utility services is**  
15 **not in conflict with any land use plans adopted by the District**  
16 **Council and approved by the Tohono O'Odham Council, and**  
17 **that the new main water line will be of substantial benefit to the**  
18 **Anegam Community, District, and the Tohono O'Odham**  
19 **Nation and to their respective members.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Council**  
24 **does hereby approve the easement for the location and**  
25 **construction by the TOUA of the new water line and all**  
26 **required utility services to serve the residents of Anegam**  
27 **Community, Sif Oidak District - Tohono O'Odham Nation.**

5 was present with a vote of 1,372.0 FOR; -0- AGAINST; 127.0 NOT  
6 VOTING; and 225.0 [11] ABSENT, pursuant to the powers vested in the  
7 Council by Section 1 (i)(1) and Section 2 (d) of Article VI of the Constitution  
8 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
9 January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
10 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
11 Act of June 18, 1934 (48 Stat. 984).




