WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a 3 new main water line and related facilities to furnish all required 4 5 utility services to the residence of Paul Andrew, Anegam 6 Community, Sif Oidak District, and has submitted a plat or 7 map thereof to the Tohono O'Odham Council showing the 8 9 location and scope of the easement and delineating the utility 10 facilities to be placed thereon; the length of easement in the 11 Anegam Community is 707.95' X 40' wide; and 12 13 WHEREAS, the Tohono O'Odham Council has determined that the routing 14 and location of the easement for all required utility services is 15 not in conflict with any land use plans adopted by the District 16 17

Council and approved by the Tohono O'Odham Council, and that the new main water line will be of substantial benefit to the Anegam Community, District, and the Tohono O'Odham Nation and to their respective members.
