

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Extending Resolution No. 93-044 to April General Session)**

**RES. NO. 93-067**

**WHEREAS, on February 2, 1993, the Tohono O'odham Rodeo & Fair Committee requested additional funds for the Annual Rodeo & Fair; and**

**WHEREAS, at this meeting the Tohono O'odham Legislative Council raised concerns regarding the Rodeo and Fair activities; and**

**WHEREAS, Resolution No. 93-044 was passed which provided that the entire Rodeo & Fair Committee report on the 1993 Rodeo & Fair activities; and**

**WHEREAS, on March 05, 1993 the Council was informed by the Committee that a full report could not be provided pending reports from the various Rodeo & Fair activities; and**

**WHEREAS, the Rodeo & Fair Committee requested a one month extension.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby extends Resolution No. 93-044 for one month.**

**BE IT FURTHER RESOLVED that the Rodeo & Fair Committee provide a report on the 1993 Rodeo and Fair activities during the April 1993 General Session.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5th day of March, 1993 at a meeting at which a quorum was present with a vote of 1,419.0 FOR; -0- AGAINST; 106.0 NOT VOTING; and 127.0 [08] ABSENT, pursuant to the powers vested in the**




