WHEREAS, as reported to the Legislative Council and the Sif Oidak District, NRCE has determined that completion of the water rights quantification and damage assessment will require an expansion of the Study area to encompass connected water basins in the Hickiwan, Gu Achi, Sells and Schuk Toak Districts; and

WHEREAS, the Nation has received an award of \$100,000 in federal funds
