

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY '94 Appropriation Request - Law Enforcement
Tohono O'odham Police Department)**

RESOLUTION NO. 93-082

WHEREAS, the Tohono O'odham Nation with a land base of 2.8 million acres and a population of 18,000 members contracts its own Law Enforcement Program under P.L. 93-638; and

WHEREAS, the Tohono O'odham Police Department is inadequately funded and understaffed to provide coverage to all areas of the Nation; and

WHEREAS, this lack of funding and staffing creates a public safety hazard for members of the Nation; and

WHEREAS, the Tohono O'odham Police Department has identified specific areas of proposed increased staffing and equipment to address this serious problem; and

WHEREAS, the Legislative Council of the Tohono O'odham Nation supports the Tohono O'odham Police Department in their request to increase their funding under P.L. 93-638.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation requests appropriation for an increase in funding for the Tohono O'odham Police Department in the amount of \$1,570,759.

BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Appropriations Committee to submit this request

in the amount identified to the appropriate members and
committees of Congress.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 23RD. day of MARCH, 1993 at a meeting at which a quorum was present with a vote of 1,617.0 FOR; -0- AGAINST; -0- NOT VOTING; and 107.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




