3 **WHEREAS, the Tohono O'Odham Nation has two districts, Chukut Kuk**  
4 **and Gu Vo District, which are bordered by the International**  
5 **United States/Mexican Boundary; and**

7 **WHEREAS, Chukut Kuk and Gu Vo District of the Tohono O'Odham**  
8 **Nation both have experienced problems with drug smuggling,**  
9 **cattle rustling and the spreading of disease from the Mexican**  
10 **cattle to the United States, Tohono O'Odham cattle; and**

11  
12 **WHEREAS, the Chukut Kuk District with the support of the Gu Vo District**  
13 **hereby requests fencing material to replace the International**  
14 **Boundary fence in order to alleviate some of the problems along**  
15 **the International United States/Mexican Boundary.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**  
18 **Legislative Council that it hereby supports the Border Fencing**  
19 **request in the amount of \$230,406.00 as outlined in the attached**  
20 **budget proposal.**

23 **BE IT FURTHER RESOLVED that the appropriate officers of the Nation are**  
24 **hereby authorized and directed to bring this request to the**  
25 **appropriate members and committees of Congress.**


