

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(In Support of Special Appropriations Funding

RESOLUTION NO. 93-088

WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 78-87 determine the inadequacy of funding affecting the timely transition of the Judicial Branch; and

WHEREAS, by Resolution No. 78-87 the Tohono O'Odham Legislative Council did recognize the base level of funding provided through P. L. 93-638 Judicial Services funding is considerably inadequate; and

WHEREAS, the Tohono O'Odham Judicial Branch has identified the areas where inadequacies exist in the current level of services; and

WHEREAS, funding would be utilized for the primary purpose of increasing the current level of services for the Tohono O'Odham Judicial Branch.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does fully support this request by the Judicial Branch of the Tohono O'Odham Nation and requests the United States Congress to appropriate additional funds to the Tohono O'Odham Nation in the amount of \$111,974.00 for the Tohono O'Odham Tribal Court's base funding level.

BE IT FURTHER RESOLVED that the appropriate officers of the Nation are hereby authorized and directed to bring this request to the

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 23RD. day of MARCH, 1993 at a meeting at which a quorum was present with a vote of 1,553.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 107.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
