

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(1994 Appropriations Request for the
Water Resources Inventory Study)**

RESOLUTION NO. 93-089

WHEREAS, the Tohono O'Odham Legislative Council establishes priorities annually for consideration by Congress; and

WHEREAS, the Legislative Council is aware that in order to complete a comprehensive water inventory, in accordance with Section 303(b) of the Southern Arizona Water Rights Settlement Act, adequate funding should be provided; and

WHEREAS, a funding level of \$9 million for a six (6) year study has been determined by the Nation's Water Resources Department; and

WHEREAS, the Tohono O'Odham Legislative Council supports the completion of the Water Inventory Study as the data collected would be of beneficial importance to the current and future generations of the Tohono O'Odham in the management of their natural resources, as identified in P. L. 97-293.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the appropriation request of the Nation's Water Resources Department in the amount of \$2,310,376.00 for FY 1994.

BE IT FURTHER RESOLVED that Congress has executed P. L. 97-293 (SAWRSA), but has not made adequate funding available to fully carry out its obligation.

10 was present with a vote of 1,086.0 FOR; 127.0 AGAINST; 404.0 NOT
11 VOTING; and 107.0 [08] ABSENT, pursuant to the powers vested in the
12 Council by Section 1 (j) of Article VI of the Constitution of the Tohono
13 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
14 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
15 1934 (48 Stat. 984).


