18 ABSENT, pursuant to the powers vested in the Council by Section 1 of Article  
19 II and Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham  
20 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
21 approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
