**RESOLUTION NO. 93-100**

**WHEREAS, the Tohono O'Odham Nation is presently operating the EARN Program under an FY 1992 P. L. 93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, the Tohono O'Odham Nation did submit its FY 92 Final Financial Report which reflects unexpended funds; and**

**WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval reflecting FY 1992 carryover funds by the EARN Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the EARN Program and requests the Bureau of Indian Affairs to carryover unexpended funds from FY 92 into FY 93 and authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the cooperative agreement, provided however, that any amendments affecting**

the funding or funding levels of the contract shall be submitted  
for further prior approval by this Council.
