

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1993 Hickiwan District Budget Amendment)**

RESOLUTION NO. 93-106

WHEREAS, by Resolution #92-455 the Tohono O'Odham Legislative Council appropriated funds to operate the Hickiwan District Government for 6 months of Fiscal Year 1993; and

WHEREAS, amendments affecting the funding level or change in the purpose for which the funds were budgeted are required to be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, Hickiwan District has submitted a budget amendment in the amount of \$51,674.00 to continue operations for another six months; from April thru September 1993.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves this amendment to increase the Hickiwan District budget amount by \$51,674.00 and authorize expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED that the amount of \$51,674.00 is hereby appropriated from the Nation's Special Reserve Account.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of APRIL, 1993 at a meeting at which a quorum was present with a vote of 1,011.5 FOR; 506.5 AGAINST; 206.0 NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham
