5 **the Bureau of Indian Affairs; and**

7 **WHEREAS, the Nation has been informed by the Bureau of Indian Affairs**
8 **of FY 1993 funding in the amount of \$500,000.00; and**

10 **WHEREAS, any amendments affecting the funding or funding levels of the**
11 **contract shall be submitted for review and approval by the**
12 **Tohono O'odham Legislative Council; and**

13 **WHEREAS, an amendment has been submitted for review and approval by**
14 **the Water Resources Study Program.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
17 **Legislative Council does hereby approve the amendment and**
18 **authorizes expenditures in accordance with the attached budget.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council**
21 **that the Tohono O'odham Nation's Officials, to wit: the**
22 **Chairman, Vice Chairman and any designated Official are**
23 **hereby authorized to negotiate and execute the contract,**
24 **provided however, that any amendment affecting the funding**
25 **or funding levels of the contract shall be submitted for further**
26 **or funding levels of the contract shall be submitted for further**
27 **prior approval by this Council.**


