**WHEREAS, the Child Day Care Services Program has been successfully  
operated through the Early Childhood Division and has served  
many Tohono O'Odham children; and**

**WHEREAS, the Tohono O'Odham Legislative Council is desirous of  
continuing this program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the proposed  
contract for FY 1994 Title XX - Child Day Care Services.**

**BE IT FURTHER RESOLVED that the duration of the contract will be from  
July 01, 1993 through June 30, 1994.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
that the Tohono O'Odham Nation's officials, to wit: the  
Chairman, Vice Chairman and any designated official are  
hereby authorized to negotiate and execute the contract,  
provided however, that any amendments affecting the funding**






