14 **identified as one means of preventing child abuse and neglect;**

17 **WHEREAS, the Tohono O'Odham Social Service Department has submitted**  
18 **an FY 1994 proposal for Community Education and**  
19 **Information Services for review and approval.**

22 **Legislative Council that it does hereby approve the application**  
23 **of the Tohono O'Odham Social Service Department for a**  
24 **contract to focus on decreasing the incidence of child abuse and**  
25 **neglect through the provision of Community Education and**  
26 **Information Services reservation wide.**


