

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1994 Elderly Title VI Program)**

RESOLUTION NO. 93-117

WHEREAS, the Tohono O'Odham Nation has successfully operated a program for the elderly members of the Nation; and

WHEREAS, funding for the operation of the Elderly Program has been possible in part by Article VI of the Older American's Act of 1965 as amended; and

WHEREAS, the Elderly Program desires to seek continued funding by submitting a proposal to the Office of Human Development Services, Administration on Aging; and

WHEREAS, the Elderly proposal will benefit elder members of the Tohono O'odham Nation by providing for their nutritional and social support services.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the proposal for continued funding of the Elderly Program to provide services to eligible members of the Tohono O'odham Nation.

BE IT FURTHER RESOLVED that the term of this grant shall commence on April 01, 1993 and end on March 31, 1994.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are

16 1934 (48 Stat. 984).
