8 **National Indian Gaming Association (NIGA) meetings; and**

10 **WHEREAS, the primary objective and purpose of the National Indian**
11 **Gaming Association is to promote, protect and preserve Indian**
12 **Gaming enterprises on Indian Country; and**

13 **WHEREAS, the Commerce Committee recommends that the Tohono**
14 **O'odham Nation renew its membership as a chartered member**
15 **of NIGA; and**

17 **WHEREAS, the committee further recommends that the Chairman of the**
18 **Commerce Committee be appointed as the official**
19 **representative to the NIGA Board of Directors.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
22 **Legislative Council hereby approves the recommendation of the**
23 **Legislative Commerce Committee to renew its membership in**
24 **the National Indian Gaming Association.**

11 Association.


12 The foregoing Resolution was passed by the Tohono O'Odham Legislative

15 and 125.0 [06] ABSENT, pursuant to the powers vested in the Council by
16 Section 1(d)(2) Article VI of the Constitution of the Tohono O'Odham Nation,
17 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved
18 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
19 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
20 984).
