

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Pisinemo District FY-93 Budget)**

RESOLUTION NO. 93-126

WHEREAS, the Tohono O'Odham Legislative Council has considered and reviewed the Pisinemo District FY-93 Budget; and

WHEREAS, said budget had previously been reviewed and revised at the Budget and Finance Committee; and

WHEREAS, suggested recommendations were discussed and incorporated into the Pisinemo District FY-93 budget; and

WHEREAS, the Pisinemo District Council through Resolution No. P-93-2 did amend its Resolution No. 12-92 thereby incorporating the recommendations from the Budget and Finance Committee and did approve its FY-93 budget request.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves the Pisinemo District budget in the amount of \$105,393.00 and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council approves funding for the Pisinemo District FY-93 budget as follows: \$93,921.00 will be provided by the Nation's Special Reserve Account; \$11,472.00 will be funded from the District funds.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 16TH. day of APRIL, 1993 at a meeting at which a quorum was present with a vote of 1,618.0 FOR; -0- AGAINST; -0- NOT VOTING; and 106.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
