8 **concerns regarding the Rodeo and Fair activities; and**

10 **WHEREAS, Resolution No. 93-044 was passed which provided that the**  
11 **entire Rodeo & Fair Committee report on the 1993 Rodeo &**  
12 **Fair activities; and**

14 **WHEREAS, on March 5, 1993 the Council was informed by the Committee**  
15 **that a full report could not be provided pending reports from**  
16 **the various Rodeo & Fair activities; and**

18 **WHEREAS, the Rodeo & Fair Committee did request a one month**  
19 **extension; and**

20  
21 **WHEREAS, by Resolution No. 93-067, the Legislative Council did extend**  
22 **this request; and**

24 **WHEREAS, at the April 16, 1993 General Session, the Nation's Vice**  
25 **Chairman, Sylvester Listo, informed Council that the reports**  
26 **were still pending and that the Rodeo & Fair Committee is**  
27 **again requesting an extension.**


**NOW, THEREFORE BE IT RESOLVED** by the Tohono O'Odham Legislative Council that it hereby extends Resolution No. 93-044.
