

**ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying the Election of Alex J. Ramon as Legislative Chairman)**

**LEGISLATIVE ORDER NO. 93-154**

2 **WHEREAS, on June 7, 1993, the Tohono O'odham Legislative Council**  
3 **proceeded with election of the Legislative Chairman; and**

4  
5 **WHEREAS, each duly elected Member of the Tohono O'odham Legislative**  
6 **Council did cast their vote for one of the following certified**  
7 **Members nominated for said office: ALEX J. RAMON or**  
8 **MARY ANN ANTONE; and**

10 **WHEREAS, Councilman Alex J. Ramon received 1,501.0 and Councilwoman**  
11 **Mary Ann Antone received 262.0; and**

13 **WHEREAS, Alex J. Ramon, having recieved a majority of the votes cast, was**  
14 **elected as Chairman of the Tohono O'odham Legislative**  
15 **Council.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham**  
18 **Legislative Council that it hereby certifies the election of and**  
19 **seats Alex J. Ramon as Chairman of the Tohono O'odham**  
20 **Legislative Council.**

22 **The foregoing ORDER was passed by the Tohono O'Odham Legislative**  
23 **Council on the 07TH day of JUNE, 1993 at a meeting at which a quorum was**  
24 **present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and**  
25 **01 ABSENT, pursuant to the powers vested in the Council by Section 1(b)**  
26 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the**  
28 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
**1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


