3 **WHEREAS, on June 7, 1993, the Tohono O'odham Legislative Council**  
4 **proceeded with appointments of Legislative Committees; and**

5 **WHEREAS, each duly elected Member of the Tohono O'odham Legislative**  
6 **Council submitted a "Declaration of Candidacy" form which**  
7 **specified their choices for Membership to the Legislative**  
8 **Committees; and**

11 **WHEREAS, the Legislative Rules, Article XII, Section 3.b. provides for**  
12 **"Retention of Current Committee Membership" for any**  
13 **Member who wishes to remain on an existing Committee; and**

15 **WHEREAS, Councilman Lloyd Francisco submitted his request to be request**  
16 **to be retained on the Rules Committee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**  
19 **Legislative Council hereby reappoints by retention Councilman**  
20 **Lloyd Francisco to the Legislative Rules Committee.**

22 **The foregoing ORDER was passed by the Tohono O'Odham Legislative**  
23 **Council on the 7TH day of JUNE, 1993 at a meeting at which a quorum was**  
24 **present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING;**  
25 **and 01 ABSENT, pursuant to the powers vested in the Council by Section**  
26 **1(b) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
27 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved**  
28 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on**  
**March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.**  
**984).**
