11 01 ABSENT, pursuant to the powers vested in the Council by Section 1(b)
12 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
13 the Tohono O'Odham Nation on January 18, 1986; and approved by the
14 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
15 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
