14 **of the Legislature in continuous service as a Legislative**
15 **Representative may request seniority preference appointment to**
16 **a Legislative Committee.**

19 **WHEREAS, there was one vacancy remaining in the Water Resources**
20 **Committee; and**

21 **WHEREAS, Councilwoman Mary Ann Antone requested Seniority Preference**
22 **Appointment for that Committee.**

24 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham**
25 **Legislative Council hereby appoints by seniority preference,**
26 **Mary Ann Antone to the Water Resources Committee.**


