

ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Amending Council's Running/Daily Agenda)

LEGISLATIVE ORDER NO. 93-180

WHEREAS, on Tuesday, June 08, 1993, the Tohono O'odham Legislative Council reviewed the agenda established for June 08, 1993; and

WHEREAS, the following items were requested for inclusion on the week's running/daily agenda:

- 1. 638 Contract Proposal for the San Lucy District (requested for the running agenda)
- 2. Supporting Resolution on the participation and management of the Gran Desierto Biosphere Reserve (requested for today's agenda.)

NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby amends the running/daily agenda to include the above-listed items.

The foregoing ORDER was passed by the Tohono O'Odham Legislative Council on the <u>08th</u> day of <u>June</u>, <u>1993</u> at a meeting at which a quorum was present with a vote of <u>1,507.5</u> FOR; <u>-0-</u> AGAINST; <u>75.5</u> NOT VOTING; and <u>180.0 [06]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1(b)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
