

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1994 Management of Health Services  
Recontract Proposal)**

**RESOLUTION NO. 93-189**

**WHEREAS, the Tohono O'Odham Nation is presently operating the  
Management of Health Services under an FY 1993 P. L. 93-638  
contract with the Public Health, Indian Health Services; and**

**WHEREAS, 42 CFR 36.205 of the Code of Federal Regulations requires that  
all proposals to recontract under P. L. 93-638 be submitted to  
the Tohono O'Odham Legislative Council for approval at least  
120 days prior to the current contract termination; and**

**WHEREAS, the Tohono O'Odham Nation does desire to recontract for  
provision of services during FY 1994; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed and  
approved the Management of Health Services FY 1994 contract  
proposal and budget.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
Legislative Council does authorize and request the Public  
Health, Indian Health Service to recontract with the Tohono  
O'Odham Nation under P. L. 93-638 regulations and  
procedures for the provision of services titled: Management of  
Health Services.**

**BE IT FURTHER RESOLVED that the duration of this recontract shall  
commence on October 01, 1993 through September 30, 1994.**

3 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council

5 that the Tohono O'Odham Nation will not fund or operate the  
6 program in the interim while negotiations are still being  
7 conducted and no executed contract has been awarded by the  
8 Indian Health Service, unless the agency authorizes and  
9 approves pre-award costs consistent with the Indian  
10 Self-Determination Act, as amended, and relevant contract  
11 regulations.

14 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council  
15 that the Tohono O'Odham Nation's officials, to wit: the  
16 Chairman, and any designated official are hereby authorized to  
17 negotiate and execute the contract, provided however, that any  
18 amendments affecting the funding or funding levels of the  
19 contract shall be submitted for further prior approval by this  
20 Council.

24 The foregoing Resolution was passed by the Tohono O'Odham Legislative  
25 Council on the 8TH. day of JUNE, 1993 at a meeting at which a quorum was  
26 present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and  
27 05 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of  
28 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
