

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1994 Equal Employment Opportunity Commission)**

RESOLUTION NO. 93-199

WHEREAS, the Tohono O'Odham Nation has operated the Tribal Employment Rights Office since 1978 and has successfully met the needs of the Tohono O'Odham; and

WHEREAS, the funding for the Tohono O'Odham Tribal Employment Rights Office has been supplemented by the Equal Employment Opportunity Commission; and

WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to eradicate employment discrimination within the exterior boundaries of the Tohono O'Odham Nation.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the continued supplemental funding for the Tribal Employment Rights Office from the Equal Employment Opportunity Commission.

BE IT FURTHER RESOLVED that the duration of this grant shall commence on October 01, 1993 through September 30, 1994.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any
