13 **review and approval the Child Adult Care Food Program**
14 **budget for Fiscal Year 1994.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**

18 **expenditures in accordance with the attached budget.**



The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of JUNE, 1993 at a meeting at which a quorum was present with a vote of 1,105.0 FOR; -0- AGAINST; 188.0 NOT VOTING; and 470.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


