(FY 1994 Adult Group Home Recontract Proposal)**

3 **WHEREAS, the Tohono O'Odham Nation is presently operating the Adult**
4 **Group Home under an FY 1993 P. L. 93-638 contract with the**
5 **Bureau of Indian Affairs; and**

7 **WHEREAS, such tribal operations have been successful and beneficial to the**
8 **Tohono O'Odham Nation and its people; and**

9 **WHEREAS, 25 CFR 271.20 of the Code of Federal Regulations requires that**
10 **all proposals to recontract under P. L. 93-638 be submitted to**
11 **the Tohono O'Odham Legislative Council for approval at least**
12 **120 days prior to the current contract termination; and**

13
14 **WHEREAS, the Tohono O'Odham Nation does desire to recontract for**
15 **provision of services during FY 1994; and**

17 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**
18 **approved the FY 1994 Adult Group Home recontract proposal**
19 **and budget.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
22 **Legislative Council that it does authorize and request the**
23 **Bureau of Indian Affairs to recontract with the Tohono**
24 **O'Odham Nation under P. L. 93-638 regulations and**
25 **procedures for the provision of services titled: Adult Group**
26 **Home Program.**

3 **BE IT FURTHER RESOLVED** that the duration of this recontract shall
4 commence on October 01, 1993 through September 30, 1994.

5 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council
6 that the Tohono O'Odham Nation will not fund or operate the
7 program in the interim while negotiations are still being
8 conducted and no executed contract has been approved by the
9 Bureau of Indian Affairs, unless the agency authorizes and
10 approves pre-award costs consistent with the Indian
11 Self-Determination Act, as amended, and relevant contract
12 regulations.

16 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council
17 that the Tohono O'Odham Nation's officials, to wit: the
18 Chairman, and any designated official are hereby authorized to
19 negotiate and execute the contract, provided however, that any
20 amendments affecting the funding or funding levels of the
21 contract shall be submitted for further prior approval by this
22 Council.

26 The foregoing Resolution was passed by the Tohono O'Odham Legislative
27 Council on the 10TH. day of JUNE, 1993 at a meeting at which a quorum
28 was present with a vote of 1,293.0 FOR; -0- AGAINST; -0- NOT VOTING;
and 470.0 [08] ABSENT, pursuant to the powers vested in the Council by
Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,




