3 **WHEREAS, the Tohono O'Odham Nation is presently operating the**  
4 **Employment Assistance Readiness Network (EARN) Program**  
5 **under an FY 1993 P. L. 93-638 contract with the Bureau of**  
6 **Indian Affairs; and**

9 **WHEREAS, such tribal operations have been successful and beneficial to the**  
10 **Tohono O'Odham Nation and its people; and**

11 **WHEREAS, 25 CFR 271.20 of the Code of Federal Regulations requires that**  
12 **all proposals to recontract under P. L. 93-638 be submitted to**  
13 **the Tohono O'Odham Legislative Council for approval at least**  
14 **120 days prior to the current contract termination; and**

17 **WHEREAS, the Tohono O'Odham Nation does desire to recontract for the**  
18 **EARN initiatives during Fiscal Year 1994; and**

19 **WHEREAS, funds for the EARN Program has been allocated by utilizing the**  
20 **Tohono O'Odham Social Service General Assistance grant**  
21 **funds; and**

22  
23 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**  
24 **approved the Fiscal Year 1994 Employment Assistance**  
25 **Readiness Network contract proposal and budget.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**  
28 **Legislative Council that it does hereby authorize and request**

8 **BE IT FURTHER RESOLVED** that the duration of the contract shall begin  
9 on October 01, 1993 through September 30, 1994.

11 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council  
12 that the Tohono O'Odham Nation will not fund or operate the  
13 program in the interim while negotiations are still being  
14 conducted and no executed contract has been approved by the  
15 Bureau of Indian Affairs, unless the agency authorizes and  
16 approves pre-award costs consistent with the Indian  
17 Self-Determination Act, as amended, and relevant contract  
18 regulations.

22 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council  
23 that the Tohono O'Odham Nation's officials, to wit: the  
24 Chairman, and any designated official are hereby authorized to  
25 negotiate and execute the contract, provided however, that any
