9 **WHEREAS, the Tohono O'Odham Nation did negotiate with the State of**
10 **Arizona and has been informed that funding available for the**
11 **project is \$30,000.; and**

13 **WHEREAS, the Tohono O'Odham Social Services Program has submitted**
14 **a budget modification reflecting the reduction of \$10,000.00 for**
15 **review and approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**
18 **Legislative Council does hereby approve the budget**
19 **modification to the Community Education and Information**
20 **Program and authorizes expenditures in accordance with the**
21 **attached budget.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**
24 **that the Tohono O'Odham Nation's officials, to wit: the**
25 **Chairman, and any designated official are hereby authorized to**


