15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**
16 **Legislative Council does hereby approve the amendment to the**
17 **JTPA Title IIA Program and authorizes expenditures in**
18 **accordance with the attached budget.**

22 **that the Tohono O'Odham Nation's officials, to wit: the**

26 **contract shall be submitted for further prior approval by this**
