8 **contract shall be submitted for review and approval by the**  
9 **Tohono O'Odham Legislative Council; and**

11 **WHEREAS, the Nation has been informed of final allocations for Fiscal Year**  
12 **1993; and**

14 **WHEREAS, an amendment has been submitted for review and approval by**  
15 **the JTPA Title IIB Summer Youth Employment Training**  
16 **Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham**  
19 **Legislative Council does hereby approve the amendment to the**  
20 **JTPA Title IIB Program and authorizes expenditures in**  
21 **accordance with the attached budget.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**  
24 **that the Tohono O'Odham Nation's officials, to wit: the**  
25 **Chairman, and any designated official are hereby authorized to**
