**WHEREAS, the Nation did submit to Arizona Department of Economic Security a Job Training Plan (JTP) for Fiscal Year 1993 and 1994 as approved by Legislative Council Resolution No. 92-239; and**

**WHEREAS, Legislative Council Resolution No. 92-239 does stipulate that any amendments affecting the delivery of JTPA Services on the Tohono O'Odham Nation shall be submitted for further prior approval; and**

**WHEREAS, the Nation has been informed by the Arizona Department of Economic Security that modifications are required to the Job Training Plan due to new JTPA Provisions established by the Job Training Reform Amendments of 1992; and**

**WHEREAS, the Nation's JTPA Program does submit for review and approval amendments to the Job Training Plan by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the amendment to the Job Training Plan for the delivery of JTPA services on the Tohono O'Odham Nation.**

delivery of JTPA services on the Tohono O'Odham Nation shall  
be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 11TH. day of JUNE, 1993 at a meeting at which a quorum  
was present with a vote of 1,409.0 FOR; -0- AGAINST; -0- NOT VOTING;  
and 354.0 [07] ABSENT, pursuant to the powers vested in the Council by  
Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved  
by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
