**RESOLUTION NO. 93-221**

**WHEREAS, the Job Training Partnership Act was enacted into law in 1982  
replacing CETA; and**

**WHEREAS, funding is made available to State and Tribal Governments to  
establish programs for improving the employment prospects of  
eligible persons through the designation of service delivery  
areas; and**

**WHEREAS, the State of Arizona is entitled to JTPA funds to develop a  
network of employment training programs throughout the State;  
and**

**WHEREAS, the Indian Reservations in Arizona have been designated as  
service delivery areas and are eligible to receive State JTPA  
funds; and**

**WHEREAS, the JTPA Program submits the following documents for review  
and approval for the Title II-C Contract Proposal for Program  
Year 1993:**

- 1) Program Year 1993 Administrative Cost Pool budget  
reflecting the final allocation of \$14,371.; and**
- 2) Program Year 1993 Program budget reflecting the final  
allocation of \$76,644.**


