8 **WHEREAS, Public Law 100-485, the Family Support Act of 1988, was**
9 **enacted into law on October 13, 1988 to revise the AFDC**
10 **Program to emphasize work, child support, and family benefits,**
11 **to amend Title IV of the Social Security Act, to encourage and**
12 **assist needy children and parents under the program to obtain**
13 **the education, training and employment needed to void long**
14 **term welfare dependence; and**

17 **WHEREAS, the JOBS Program has submitted a budget for Fiscal Year 1994**
18 **for review and approval by the Tohono O'Odham Legislative**

program in the interim while negotiations are still being conducted and no executed grant has been awarded by the Department of Health and Human Services, Family Support Administration.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11TH. day of JUNE, 1993 at a meeting at which a quorum was present with a vote of 1,639.0 FOR; -0- AGAINST; -0- NOT VOTING; and 124.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
