WHEREAS, the Legislative Council has the authority to provide for the administration of justice under Article VI, Section 1(c)(6) of the Tohono O'Odham Constitution; and

WHEREAS, on the 14th day of December 1989, the Legislative Council enacted Ordinance No. 01-89 (designating Judicial Branch Rules & Procedures as Title II with enactment of Chapters 1 & 2); and

WHEREAS, Chapter II, Section 2-112 of the Judicial Branch Rules & Procedures entitled Fees Received by Clerk of the Court, establishes the authority for the collection of fees by the Court; and

WHEREAS, Chapter II, Section 2-112(b) of the Judicial Branch Rules and Procedures directs the Clerk of the Court to transmit to the Tribal Treasurer, monies collected for fees, for deposit in the Tohono O'Odham Judiciary's fund; and

WHEREAS, there currently exists for the administrative fees account two (2) line items designated as Program Supplies and Office Supplies; and

WHEREAS, the Tohono O'Odham Judiciary desires to add two (2) additional line items to be designated as Office & Communication

Capital Equipment.**






