4 **Specialty Training Program under FY 1993 P. L 93-638 contract**
5 **with the Indian Health Services; and**

7 **WHEREAS, the Nation has been informed of its FY 1993 allocation in the**
8 **amount of \$17,440.; and**

9 **WHEREAS, any amendments affecting the funding or funding levels of the**
10 **contract shall be submitted for review and approval by the**
11 **Tohono O'Odham Legislative Council; and**

13 **WHEREAS, an amendment has been submitted for review and approval by**
14 **the Community Health Services Program.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
17 **Legislative Council that it does hereby approve the amendment**
18 **to the CHR Specialty Training Program contract and authorizes**
19 **expenditures in accordance with the attached budget.**

21 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**
22 **that the Tohono O'Odham Nation's officials, to wit: the**
23 **Chairman, and any designated official are hereby authorized to**


