4 **Development Indian Home Grant Program has made \$10 million**
5 **dollars available to all reservations nationwide for the purposes**
6 **of providing new homes and renovations to existing homes for**
7 **Native Americans in need of housing and housing repairs; and**

9 **WHEREAS, HUD guidelines require quality housing standards and/or**
10 **building codes as a pre-requisite for the Indian Home Grant**
11 **program applications; and**

13 **WHEREAS, the Nation recognizes the need for such standards and building**
14 **codes to ensure quality housing for all members of the Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED** by the Legislative Council that the
17 **housing quality standards set forth in the United States**
18 **Department of Housing and Urban Development's Public**
19 **Housing Agency Administrative Practices Handbook for the**
20 **Section 8 Existing Housing Program, 7420.7 and Sections**
21 **882.109, 882.210 and 882.211 of Section 8 Existing Regulations,**
22 **shall become the standards for HUD Indian Home grant**
23 **proposed homes within the boundaries of the Nation for FY**




