RESOLUTION NO. 93-236

WHEREAS, the University of Arizona presented a proposal to the Nation for a substance abuse treatment program for non-incarcerated criminal and juvenile justice populations under a grant with the Center on Substance Abuse Treatment (CSAT); and

WHEREAS, this project will target individuals with alcohol or substance-abuse problems going through the criminal justice process; and

WHEREAS, this project will provide additional and enhanced services and work in conjunction with the Alcoholism Program and other existing tribal entities or agencies; and

WHEREAS, the Judiciary and Health & Human Services Committees, as the oversight committees, did review the proposal and recommend support from the Legislative Council.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby support grant application by the University of Arizona to the Center of Substance Abuse Treatment (CSAT) for funding of a substance abuse treatment program to benefit the Tohono O'odham.






