

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the Production of a Video Program
about the Tohono O'Odham)**

RESOLUTION NO. 93-239

WHEREAS, the Council has been informed of a proposal to produce a video program on the Tohono O'Odham and their way of life; and

WHEREAS, the Council is of the opinion that such a video program would be of great value to both O'Odham and non-O'Odham as an educational tool and as a historical record of O'Odham culture; and

WHEREAS, the Council is confident that with Michael A. Enis, an O'Odham, as project director, a program can be developed which is both an accurate and sensitive portrayal of the O'Odham way of life.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby express its support for the video project proposed by Michael A. Enis.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH, day of JULY, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(2) & (8) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
