

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting Development of a Voter Education Videotape
in the O'Odham Language)**

RESOLUTION NO. 93-249

WHEREAS, the Legislative Council has been informed of a proposal by the Pima County Division of Elections to produce an instructional videotape on the Arizona electoral process in the O'Odham language; and

WHEREAS, the Legislative Council believes that the availability of voter information in O'Odham would enable tribal members with limited English language fluency to participate more fully in the state electoral process; and

WHEREAS, the Council further believes that such an effort would be consistent with Pima County's obligations to the Tohono O'Odham residing within the County under the Voting Rights Act of 1965, as amended by the Voting Rights Language Assistance Act of 1992, to provide voting materials in the O'Odham language.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby endorse and support the project proposed by the Pima County division of Elections to produce an instructional videotape in the O'Odham language to assist tribal members in exercising their right to vote in state elections.


