**WHEREAS, the Tohono O'odham Nation is presently operating the JTPA
Title II-B JTPA Program under an FY 1994 grant with the
Unites States Department of Labor; and**

**WHEREAS, the Nation has been informed of additional funds in the
amount of \$29,730.00 for the JTPA Title II-B Summer
Youth Employment Training Program for Calendar Year
1993 ; and**

**WHEREAS, the Tohono O'Odham Nation has submitted its close-out
report to the Department of Labor which identifies for FY
1992 a carry-over amount of \$118,314.00; and**

**WHEREAS, any amendments affecting the funding or funding levels of
the grant shall be submitted for review and approval by the
Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted to reflect the additional
appropriation of \$29,730.00 and Fiscal Year 1992 carry-over
amount of \$118,314.00 for review and approval by the JTPA
Title II-B Summer Youth Employment Training Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council does hereby approve the amendment to

Council by Section 1(f) of Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
1986; and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
